SUPER PET EXPO LIABILITY WAIVER

By my purchase of tickets to attend Super Pet Expo and participation in various events and activities at Super Pet Expo, including Puppy Playground, Ultimate Dog Ball Pit, Doggie Derby, Doggie Dash and Luring (collectively, the “**Event**”), I agree to the following for myself, my invitees, my guests, and, if applicable, my pets:

For the purposes of this waiver, Chandler Venture Group, Inc., All Show Services, and all of their owners, affiliates, managers, agents, attorneys, staff, volunteers, heirs, representatives, are referred to as the “**Releasees**.”

Acceptance of Liability: I accept and assume that there are certain risks associated with attending the Event, which may result in harm to myself, my property, and my pet, if I attend with my pet. I further accept and assume that my pet may harm other individuals, their property, and their pets and that I may be harmed by the pets of other persons attending the Event. Therefore, in consideration for admission to the Event, I agree to the following:

- **Release of Claims for Harm to Myself and My Property:** I waive and release any and all claims that I may have against Releasees for any and all injuries that may occur to me or my property or my pet as a result of my participation in and attendance at the Event.
- **Release of Claims for Harm to Other Individuals and their Property:** I agree to hold Releasees harmless for any claim for loss or injury which may be alleged to have been caused by my pet or the pets of other while in or upon premises of the event. I accept full responsibility and liability for any damage caused by my pet, and will indemnify, defend and hold harmless the Releasees against all such claims.

Eligibility Requirements: I confirm, by purchasing admission to the Event that my pet meets the following eligibility requirements:

- I certify that my pet is current with the vaccinations required by law, and that my pet is healthy to the best of my knowledge.
- I certify that my dog or cat is at least 17 weeks of age, and/or that my non-mammalian animal is at least 8 weeks of age.
- I certify that my pet has not shown any of the following symptoms in the last 7 days: cough, runny nose, fever, lethargy, eye discharge, or reduced appetite.
- I certify that my pet has not bitten, caused bodily or property damage, or shown aggression in the past.
- I certify that my pet is not a hazard to other individuals or animals.

Rules and Regulations: I agree, by purchasing admission to the Event, to abide by the following rules and regulations:

- I will be solely responsible for cleaning up any messes made by my pet.
- I will report any incidents involving pets to the show staff immediately.
- I will be in full control of my pet at all times.
- I will ensure that my pet is on a non-retractable leash, not exceeding 48” in length.
- I will adhere to any and all rules and obey the Event staff and security.
- I recognize that the Releasees reserve the right to stop or limit any individual or pet’s participation for whatever reason they feel may adversely affect the safety of any participating individual or their pet.

Acknowledgement: I acknowledge that I have been given an opportunity to ask questions about this waiver, and understand that this shall be binding on me, my heirs, legal representatives, successors, and assigns, and shall inure to the benefit of the Releasees.

This waiver shall be governed by the laws of the State of NEW JERSEY or the laws of the Commonwealth of VIRGINIA, as applicable based on the location of the Super Pet Expo, for all purposes without regard to any conflict of laws principles.
